EXPENDITURES THAT EXCEED COUNTY SPENDING POLICY APPROVED

Charlie Morris made the motion to approve the expenditures that exceed the County spending policy as follows: putting a \$2,000.00 limit on constructing a building for the roll-off attendant. On a second by Dennis Wyatt, the motion was unanimous.
