## August 22, 2016

Be it remembered that on August 22, 2016, the Honorable Commissioners Court met in Regular Session with these members present, to-wit: County Judge Kevin Brendle. Commissioners Dennis Wyatt, Precinct #1, Mike Smith, Precinct #2, Charlie Morris, Precinct #3, Sheldon Parsons, Precinct #4, Darla Thomason, Treasurer, and Becky Hill, County and District Clerk. The meeting was called to order at 9:30 a.m. by County Judge, Kevin Brendle. The meeting opened with a prayer by Woodie McArthur, followed by the Pledge of Allegiance to the U.S. Flag and the Texas Flag.

Whereupon the following business was transacted and is now placed of record in the minutes of said Court:

## **CONSENT AGENDA ITEMS**

Minutes of the July 11, 2016 meeting were reviewed with following correction:

Texas Historical Commission will meet the week of July 22<sup>nd</sup>, 2016 to discuss the restoration grant.

- Sheriff Terry Braly was not present but submitted the Sheriff's Department report. There were a total of 301, 9-1-1 calls, and 176 other calls. There was a total of 13 prisoners held.
- Nancy Stone, J.P. presented the Justice of the Peace report to the Court. Total cases filed for June was 84, and total revenue collected was \$10,252.82.
- Rebecca Haney, Tax Assessor Collector submitted the Tax Office report. Tax
  Collections for Dickens County were: current, \$10,842.23, \$826.04 delinquent collected,.
  Tax Collections for Road and Bridge were: current, \$2852.45, delinquent collected,
  \$297.19.
- Becky Hill, County and District Clerk, presented the Clerk's office report. Total revenue in the amount of \$2845.40 for fines, fees and court costs was collected. In County Court, Kevin Brendle presiding, there was 1 criminal mischief, 1Possession of Marijuana, 2 Terrorist threat, 1 possession controlled substance, and 1 interference with emergency call, 1 Probate cases filed, 1 Muniment of Title heard and 2 DWLI cases heard. In the 110th Judicial District Court, Judge William P. Smith, presiding, there was 1 Judgment NISI, 4 Delinquent Tax cases filed, and 1 Attorney General case filed; 1 Divorce heard.
- Darla Thomason, County Treasurer presented the treasurer's report. Fund Balances as of July 31, 2016 were: General Fund \$-29,669.97, Road and Bridge, \$18,669.31, dedicated fund balance \$63,334.87.
  - Wildlife Service Report was presented to the court by Clint Martin. Mr. Martin reported the elimination of 15 coyotes, 16 pigs, 6 skunks, 4 raccoons and 3 possums.
  - Wes Abbott, Emergency Management Coordinator, gave his report. Abbott requested that the county keep track of all equipment and hours used during fires in order to qualify for grant money. The county is need of a coordinator to organize donations and volunteers during fires and other disasters. There will be classes held for Emergency Responders in Garza County on September 9-11 and also classes on October 25-26. For further information you can contact Wes Abbott or Kevin Brendle. Fema will be meeting with the commissioner in the near future to survey completed projects.

- The commissioners gave their reports on road conditions in their respective precincts and reported that all annual road reports had been completed and delivered as required.
   Mike Smith reported that they were laying wrap in intersections and washes and that the maintainer was in need of tires
- Dickens County Treasurer submitted request to pay invoice to Komatsu, Inc. in the amount of \$2948.00.
- County Treasurer request the court authorization to pay West Tex Graphics invoice in the amount of \$242.00.
- Continuing Education Units (CEU) were accepted for Dennis Wyatt and Sheldon Parsons.
- Estimates for Garage doors was presented to the court for discussion by Mike Smith for the County Barn.

Motion was made by Dennis Wyatt and seconded by Charlie Morris to approve the consent agenda items listed above. Vote was unanimous.

Sheldon Parsons made the motion to adopt the proposed property tax rate of .778421 per hundred as presented to the court. Dennis Wyatt seconded the motion. Motion passed to adopt the proposed tax rate 3/2 with Mike Smith and Dennis Wyatt opposed.

- Dennis Wyatt made the motion to approve and pay all bills as submitted with the exclusion of Wyatt Tractor Service. Mike Smith seconded the motion. Motion passed unanimously.
- On motion made by Mike Smith and seconded by Kevin Brendle, the court voted in favor of paying Wyatt Tractor Services. Dennis Wyatt abstained from voting
