# **JULY 11, 2016**

Be it remembered that on July 11, 2016, the Honorable Commissioners Court met in Regular Session with these members present, to-wit: County Judge Kevin Brendle. Commissioners Dennis Wyatt, Precinct #1, Mike Smith, Precinct #2, Charlie Morris, Precinct #3, Sheldon Parsons, Precinct #4, Darla Thomason, Treasurer, and Becky Hill, County and District Clerk. The meeting was called to order at 9:02 a.m. by County Judge, Kevin Brendle. The meeting opened with a prayer by Charlie Morris, followed by the Pledge of Allegiance to the U.S. Flag and the Texas Flag.

Whereupon the following business was transacted and is now placed of record in the minutes of said Court:

## **CONSENT AGENDA ITEMS**

Minutes of the June 13, 2016 meeting were reviewed with following correction:

"EMS PROCEDURE APPROVED" should read: EMERGENCY PROCEDURE DOCUMENT APPROVED Judge Kevin Brendle presented the changes to the Emergency Procedures. Charlie Morris moved to accept changes and approve the Emergency Procedures as presented. Dennis Wyatt seconded. Motion carried unanimously."

- Sheriff Terry Braly was not present but submitted the Sheriff's Department report. There were a total of 292, 9-1-1 calls, and 214 other calls. There was a total of 8 prisoners held.
- Nancy Stone, J.P. presented the Justice of the Peace report to the Court. Total cases filed for June was 105, and total revenue collected was \$16,115.08.
- Rebecca Haney, Tax Assessor Collector submitted the Tax Office report. Tax
   Collections for Dickens County were: current, \$3,063.75, \$728.85 delinquent collected,.

   Tax Collections for Road and Bridge were: current, \$806.06, delinquent collected, \$257.27.
- Becky Hill, County and District Clerk, presented the Clerk's office report. Total revenue in the amount of \$4249.75 for fines, fees and court costs was collected. In County Court, Kevin Brendle presiding, there was I DWLI, 1Possession of Marijuana, and 1 illigal license cases filed, 1 criminal cases heard. 1 civil case transferred to District Court. In the 110<sup>th</sup> Judicial District Court, Judge William P. Smith, presiding, there was 1 forgery 1 theft of property, 1 aggravated assault, and 1 assault on public servant. 2 civil cases filed, 9 Tax case filed.
- Wildlife Service Report was presented to the court by Clint Martin. Mr. Martin stated that he had been working mainly in Spur and had killed 3 possums, 3 raccoons, 2 skunks, 7 swine and numerous gophers.
- Darla Thomason, County Treasurer presented the treasurer's report. Fund Balances as of June 30, 2016 were: General Fund \$-40,416.61, Road and Bridge, \$-8,922.32, dedicated fund balance \$61,959.87.
  - The commissioners gave their reports on road conditions in their respective precincts. All stating they were mainly spraying ditches and hauling gravel because of dry conditions. Also in discussion was the road and bridge report being past due.
  - Dickens County Treasurer submitted request to pay invoice to Komatsu, Inc. in the amount of \$3099.98.

- County Treasurer request the court authorization to pay KBL Restoration invoice in the amount of \$61.683.27.
- Authorization for County Treasurer Darla Thomason to replace Sandy Vickery as Dickens County Indigent Health Care Privacy Officer was discussed.
- Discussion to approve the 21% Federal Poverty Guidelines minimum standard as the Dickens County Indigent Health Care monthly income statement.
- Approval of invoice from \$3250.00 from Double X Range Works, which exceeds the County spending policy.

Motion was made by Mike Smith and seconded by Sheldon Parsons to approve all consent agenda items listed above. Vote was unanimous.

#### SOS WASTE PRESENTATION

Gary Regner and Jimmie Ivins met with the Commissioners Court to discuss Roll-Off Site waste services for the County. No action taken.

#### FUEL BIDS APPROVED

Fuel bids were submitted to the court from WTG Fuels, Crosby County Fuel and Farmers Coop. On motion by Sheldon Parsons and a second by Charlie Morris all fuel bids were accepted as presented. Motion passed unanimously.
