# MINUTES OF COMMISSIONER'S COURT March 20, 2017

Be it remembered that on March 20, 2017 the Honorable Commissioners Court met in Regular Session with these members present, to-wit: County Judge Kevin Brendle. Commissioners Dennis Wyatt, Precinct #1, Mike Smith, Precinct #2, Charlie Morris, Precinct #3, Sheldon Parsons, Precinct #4, Darla Thomason, Treasurer, and Becky Hill, County and District Clerk. The meeting was called to order at 9:05 a.m. by County Judge, Kevin Brendle. The meeting opened with a prayer by P. J. Schmidt, followed by the Pledge of Allegiance to the U.S. Flag and the Texas Flag.

Whereupon the following business was transacted and is now placed of record in the minutes of said Court:

### **CONSENT AGENDA ITEMS**

Minutes of the February 13, 2017 meeting were reviewed and approved.

- Sheriff Terry Braly submitted the Sheriff's Department report. There were a total of 229, 9-1-1 calls, and 129 other calls. There was a total of 9 prisoners held.
- Nancy Stone, J.P. presented the Justice of the Peace report to the Court. Total cases filed for January was 33, and total revenue collected was \$5,143.40.
- Rebecca Haney, Tax Assessor Collector Presented the Tax Office report. Tax Collections for Dickens County were: current, \$50,153.57, delinquent collected \$2,174.53. Tax Collections for Road and Bridge were: current, \$11,972.09, delinquent collected, \$599.11.
- Becky Hill, County and District Clerk, presented the Clerk's office report. Total revenue in the amount of \$2883.65 for fines, fees and court costs was collected. In County Court, Kevin Brendle presiding, 7 criminal cases were filed and 1 probate case heard. In the 110<sup>th</sup> Judicial District Court, Judge William P. Smith, presiding, there was 11 criminal cases filed and 2 Attorney General cases heard.
- Darla Thomason, County Treasurer presented the treasurer's report. Fund Balances as of February 29, 2017 were: General Fund \$-46,563.87, Road and Bridge, \$11,637.16, dedicated fund balance \$71,961.87.
- Thomas Boyle, county extension agent, presented his report to the court. Extension office has been busy with stock shows, fashion shows and other activities. The 4-H members are starting to work on the arena in Dickens to begin play days there.
- Clint Martin, Wildlife Services presented his report to the court. Fifty seven coyotes and 31 swine were destroyed in February. Airplane has been flying. Mr. Martin also stated that swine poison will not be used in his program due to the uncertainty of secondary effects it might have on the environment.
- County commissioner reported on the road conditions in their precincts. All precincts are grading roads, hauling gravel and pulling ditches. Additional gravel pits are needed to continue to supply the counties needs.
- Harry Bob Martin present the Historical Commission report. The last two school markers have been placed. Historical Markers have been indexed. Cemetery indexing was maintained and updated. Most of the work has been done on the Palace Theater Currently working on restrooms, lobby, doorways, and securing projection equipment. Hopefully the

theater will be operational for homecoming this year. Brummett building in Dickens is in need of repainting. Repairs on the Dickens Springs wagon will be fixed with expanded metal.

• Invoices presented to court for approval included KBL in the amount of \$5,283.90. Lubbock Grader Blades in the amount of \$1,675.80.00, Spur Farmers Coop Gin & Supply in the amount of \$3,080.00 for Precinct 3 tires, Double X Rangeworks in the amount of \$2500.00.

Motion was made by Mike smith and seconded by Charlie Morris to approve all the consent agenda items as presented. Vote carried unanimously.
