PURCHASE THAT EXCEEDS SPENDING POLICY APPROVED

Dennis Wyatt made the motion to approve the purchase of chemicals for Road and Bridge, Precinct 3 & 4, at a cost of \$3,445.00, which exceeds the County's spending policy of \$1000.00. On a second by Ricky West, the motion was unanimous.

INVOICE FROM KOMATSU ARCHITECTURE APPROVED

On a motion by Ricky West, and a second by Charlie Morris, the Court voted unanimously to approve an invoice in the amount of \$20, 370.36 (\$864.00, travel and \$19, 506.36 design) submitted by Komatsu Architecture for schematic design of the Courthouse Annex.
