August 13, 2018

Be it remembered that on August 13, 2018 the Honorable Commissioners Court met in Regular Session with these members present, to-wit: County Judge Kevin Brendle, Commissioners Dennis Wyatt, Precinct #1, Mike Smith, Precinct #2, Charlie Morris, Precinct #3, Sheldon Parsons, Precinct #4, and Becky Hill, County and District Clerk. The meeting was called to order at 9:05 a.m. by County Judge, Kevin Brendle. The meeting opened with a prayer by Jesse Gillham, Pastor of Dickens Baptist Church, followed by the Pledge of Allegiance to the U.S. Flag and the Texas Flag.
